### **SUPERINTENDENT'S OFFICE**

**Procedure for Filling Vacant Board Position****ACTION ITEM****Background Information:**

Effective September 29, 2025, Trustee Katherine H. Smith resigned as a Trustee of the Anaheim Union High School District. Trustee Smith's resignation has created a vacancy on the Board of Trustees. The term Trustee Smith was elected to does not expire until December 2028. The Board of Trustees will need to fill the vacancy created by Trustee Smith's resignation.

**Current Consideration:**

Pursuant to Education Code Section 5091 and Board Policy 10221, the Board of Trustees is required to fill any vacancy by making a provisional appointment or by calling for a special election. The Board of Trustees must complete this process within 60 days of the vacancy. If the Board of Trustees does not make a provisional appointment or order an election within 60 days, the county superintendent of schools will call for an election to fill the vacancy. Board Policies 10111 and 10221, as well as Education Code Section 5091(a) outline other procedural information on the filling of a Board vacancy.

**Budget Implication:**

A provisional appointment to fill the vacancy has no budget impact. A special election to fill the vacancy will require the District to fund the cost of a special election.

**Staff Recommendation:**

It is recommended that the Board of Trustees fully discuss this matter and take formal action at this meeting to determine which method will be used to fill the Board vacancy. Taking this action will provide direction for staff on the intended method of filling the vacancy.
