Driving and Parking Regulations:

The following regulations have been developed to ensure the safe use of motor vehicles, trucks, motorbikes and scooters on campus. These rules apply to all persons who drive or park on any Anaheim Union High School District's school campus. All regulations will be enforced by the local police department, along with school officials.

- ✓ Parking Permits must be affixed to the lower left corner of the front window while on campus grounds.
- Strict obedience to police officers and/or authorized school officials as well as all authorized signs and other traffic control devices is required at all times.
- Parking Permits are for the current school year only or until the insurance policy on file expires. The parking lot is off limits except for arriving or leaving school. Students will not be permitted to return to their vehicles during the school day.
- ✓ Parking Permits are the responsibility of the student and no lost or stolen parking permits will be reissued without a fee.
- ✓ Parking Permits are for identification only and do not guarantee a parking space.
- ✓ The campus speed of 5 M.P.H. is to be observed by all drivers at all times while on campus grounds.
- ✓ Vehicles must be parked forward facing within designated student-parking spaces.
- ✓ No parking on crosswalks, sidewalks, yellow areas, driveways, red zones, fire lanes, no parking zones, in any area which hinders normal traffic flow, in visitor or staff parking stalls or handicapped stalls without a valid handicapped placard.
- Park at your own risk. Vehicles must be locked while parked on campus grounds as the Anaheim Union High School District or school campus is not responsible for damage to any vehicle or lost articles.
- The parking lot is part of the school campus and because state laws consider a vehicle to be an extension of the student's person, illegal items should not be in cars while parked on campus. ALL cars parked on campus grounds are subject to search when a school official reasonably suspects that the vehicle contains illegal items that violate any laws or school campus rules.
- ✓ No student is allowed to leave the parking lot in his/her vehicle without a valid OFF CAMPUS PERMIT during school hours.
